

Lessons from the Pandemic

As the COVID-19 pandemic enters its third year, health authorities have called on countries to strengthen surveillance and bridge gaps in vaccination coverage to end the emergency and better prepare for future health crises. The U.S. intends to end the public emergency for COVID-19 on May 11, 2023 and other countries will likely follow suit.

Effective last February 1, 2023, the Coronavirus Tracker switched from LIVE to daily updates. A number of countries have now transitioned to weekly updates with no longer the need for immediate updates.

Over the past three years, the global statistics have recorded 682,798,511 reported cases, 6,821,650 deaths and 655,718,737 recoveries. There are 20,258,124 active cases as of March 22, 2023.

The pandemic underscored that no country or organization was fully prepared for the impact of the coronavirus pandemic including developed nations which were also marked by a melange of inequities.

Today, incidence rates are 20-30 times less than a year prior. But while the crisis hasn't completely resolved, we are currently in a much secure position. The WHO has highlighted key elements in directing countries get to this place. One important point includes building and strengthening the COVID-19 global genomic surveillance which is key to tracking the evolution of the virus, as well as monitoring for other pathogens with pandemic potential.

A crucial lesson learned from the COVID pandemic is the recognition of the need for global collaboration in strengthening genomic surveillance.

Over the past three years, more than 1.2 million coronavirus genome sequences from 172 countries have been shared into global databases, a testament to the tremendous work and dedication of researchers around the world during the pandemic. Because of this, the WHO has coordinated the development of the 10-year global genomic surveillance strategy for pathogens with pandemic and epidemic potential 2022 - 2032. The initiative is powered by a vision to inform, coordinate and strengthen genomic surveillance efforts at country, regional and worldwide levels. Genomic surveillance is part of the broader surveillance and laboratory system, and its implementation should reinforce capabilities including sample collection, diagnostics, data sharing and analysis. The strategy aims to facilitate the connectivity between different disease control programs and surveillance networks. This interoperability will strengthen the cross-cutting essential public health laboratory

functions underpinning genomics holistically. The strategy places emphasis on the broad-scale goal, objectives and strategic actions needed. These are dependent on commitments from countries, agencies and the WHO for their implementation.

What other lessons can we derive from the global pandemic?

We must to take mental health seriously.

There was a rise in reported mental health problems that have been described as "a second pandemic," highlighting mental health as an issue that requires addressing. Many psychiatrists and neurologists believe the number of mental health disorders that rose during the pandemic continues to increase as people grapple with such matters as work stress, job loss, isolation, and losing a family member to COVID-19.

We have the capacity for resilience.

During the pandemic in facing the relatively unknown threat of the novel virus, the PCS undertook efforts to protect both patient and the surgeons by enforcing safety measure guidelines. While each individual's situation is uniquely different, many have realized the possibility to be resilient during this health crisis. People have practiced self-care in a multitude of ways during the pandemic as they were forced to adjust to new work schedules, family routines, and the ability to cut back on socializing. Many sought out new strategies to counter the stress.

Community is essential and technology has made this possible during the severe lockdown periods.

The pandemic forced others to realize the importance of human social connectivity. We have managed to maintain social connections and continuing medical education with the use of technology to keep up to date. There can be no doubt that the establishment of communication and connectivity has been immensely beneficial on several levels. There is a need for proper regard for the unknown and respect for medical science.

Humankind required this wake-up dose of humility. Scientists and non-scientists alike learned that a virus can be more powerful than calculated. This was evident in the manner knowledge about the virus has changed over time in the past 3 years as scientific investigation of it has likewise evolved.

Conspiracy theories are still circulating concerning COVID-19.

While the world has been battling a pandemic the past 3 years, it also has been combating an infodemic. A sizeable segment in society have retrogressed back on the trusted, traditional news media channels as the main providers of pandemicrelated information and have become more inclined to believe conspiracy theories and misinformation churned out by the alternative social media.

A one-way ANOVA study by David de Coninck, et al. published last April 2021 revealed that the Philippines ranked the highest for beliefs in conspiracy theories and misinformation. Mean scores indicated that respondents from the Philippines (M = 5.83), the United States (M = 5.19), and Hong Kong (M = 5.03) reported the highest scores with regards to conspiracy beliefs while respondents from same three countries [Philippines (M = 4.91), Hong Kong (M = 4.06), United States (M = 3.73)] reported the highest belief in misinformation.

The WHO has warned that COVID-19 is still in circulation and the virus has yet to settle into a predictable pattern. In addition, the WHO has cautioned that though testing rates have considerably decreased, it is crucial that countries maintain and continue to strengthen surveillance as the SARS-CoV-2 virus can still evolve.

We must focus on recovering losses and on rebuilding resilient health systems and being better prepared for future global health threats.

FROM THE PRESIDENT





P.S.B.

Three months of 2023 are nearly over as of this writing. As PCS President, I have attended chapter and specialty society inductions, countless meetings, met people I have not met before. All of these you will be able to read in the minutes of the meeting, as part of the President's update in "Across the Board". There are some matters, though, that need more elucidation to the Fellows, hence I am writing here, specifically about the "Physician's Act".

Republic Act 2382 or the Medical Act of 1959, and as amended in 1965 by RA4224 and in 1968 by RA 5946, is the foundation of medical practice in our country. It contains the curriculum, the schedule of examinations in the Physician Licensure Exams, etc. In the last 5 years or so, the College has been hard at work on the Physician's Act. Sometime in 2019, the Physician's Act, as submitted to Congress was on its second reading. It contained provisions that would have put specialty training and certification under the DOH, criminalization of malpractice, among others.

Dr. George Lim, then 2019 PCS President, spearheaded writing a law that was a "Physician's Act as written by physicians". He gathered the heads and representatives of the Specialty Divisions under the Philippine Medical Association namely: Anesthesia, Family Medicine, Internal Medicine, Radiology, Pathology, Pediatrics, Obstetrics and Gynecology and Surgery. The group met close to 4 months, every 2 weeks till nearly midnight at the PCS Building. Other groups were invited to ask their inputs, particularly the PMA and the PRC.

The 1959 Medical Act (as amended 1965 and 1969) was reviewed by the group and the work was divided into 4 working groups, each in charge of writing different sections of the bill. As the weeks progressed, each version underwent scrutiny, word for word, line by line, vis-à-vis the latest versions submitted by the groups. As PCS Board Secretary then, I attended

each meeting and would do final proof reading of the versions produced by the group. An audience was also sought with Congressman Angelina Tan who had filed a bill in Congress for amendment of the Physician's Act of 1959; likewise an audience was sought with Senator Lawrence Go, Chair of the Senate Committee on Health. A meeting was also held with the PRC Board of Medicine, the specialty divisions, other doctors' groups in the office of Dr. Angelina Tan. In January 2020, copies of the completed proposed bill, the output of the Specialty Divisions of the PMA, were submitted to different lawmakers: Congress Chairman Committee on Health, Speaker of the House, Minority Floor Leader; to the Senate Chairman Committee on Health, Senate President, Senate Minority etc.,, DOH Secretary, the PMA President, the PRC Chairman, the PRC Board of Medicine, among others.

Then Covid happened. The momentum the group had gained was put on hold as the pandemic gripped the world and our country in March 2020. The 18th Congress of the Philippines meanwhile tackled bills pertaining to the health crisis. This lasted till the end of the 18th Congress on June 1, 2022. By July 2022, the19th Congress had now assembled and the bill was once again revived and hearings started.

The specialty divisions realized that, although indeed the bill needed to be seen by the Committee on Health, it was the Committee on Civil Service and Professional Regulation that had jurisdiction over bills covering professions in the Philippines. The group also noted that a large part of the bill being considered in Congress contained sections that were proposed by the specialty divisions. The lawmakers indeed had appreciated the input from the Specialty Divisions.

Dr. Lim again convened the Specialty Divisions group sometime in July 2022 to rewrite portions of the Physician's Act that could be improved based on

proceedings of various meetings with the PRC, PRBOM, PMA and others. A newer version was drafted and sent again to the different stakeholders as above.

During the 2022 PCS Annual Clinical Congress, Congressman Ciriaco Gato, Jr., chair of the Committee on Health and myself had a talk regarding this bill. I requested that the PCS be included in meetings and in hearings that the Congress Committee on Health would have regarding the Physician's Act. By 2023, the PMA had now arranged meetings with the Specialty Divisions, the PRC, the DOH, the CHED. In January 2023, meetings were held with Congressmen Gato, Golez, Miguel and Tan; Dr. Lim attended on behalf of the PCS. Another meeting was held in February 2023, convened by the PMA regarding the bill. Corollary to these, various exchanges were made via Viber and text messages between the PMA and the Specialty Division Heads. Zoom meetings were also arranged with members of the specialty societies in attendance.

By the first week of March 2023, an invitation was sent by the Congress to attend the Committee on Civil Service and Professional Regulation Joint with Committee on Health Hearing on March 22, 2023 at the Nograles Hall in the House of Representatives. This was a continuation of deliberation and approval of bills on the Physician's Act by which medicine would be governed, namely:

- HB No. 688 An Act Providing for a Physician's Act Repealing for the Purpose Republic Act No. 2382, as Amended, Otherwise Known as the "Medical Act of 1959" authored by Rep. Keith Micah "Atty. Mike" D.L. Tan
- HB No. 1591 An Act Expanding the Scope of Medical Practice through Providing Guidelines for Telemedicine Services, Amending Republic Act No 2382, or Medical Act of 1959, and For Other Purposes authored by Reps. Yedda Marie K. Romualdez, Jude A. Acidre.
- HB No. 6112 An Act Providing for a Physician's Act Repealing for the Purpose Republic Act No. 2382, as Amended, Otherwise Known as the "Medical Act of 1959", authored by Rep. Ciriaco B. Gato, Jr.
- HB No. 6137 An Act Providing for a Physician's Act Repealing for the Purpose Republic Act No. 2382, as Amended, Otherwise Known as the "Medical Act of 1959" authored by Rep. Ray T. Reyes.

On March 22, 2023, the PMA, represented by President Minerva Calimag, PMA Vice-President

Hector Santos, PCP President Dr. Diana Payawal, the PCS represented by Dr. George Lim and myself as PCS President attended the hearing as resource persons. Other attendees were PRC Commissioner Dr. Jose Cueto, PRC Board of Medicine Chair Dr. Godofreda Dalmacion, members of the PRC Board of Medicine, the Department of Health, the Department of Budget and Management and others. Rep. Ciriaco Gato, Jr. MD chair of the Congress Committee on Health, Rep. Kristie Alexie Tutor, chair of the Committee on Civil Service and Professional Regulation, presided.

Discussions centered on the integration of the profession, the identification of the integrated national organization of physicians, the deletion of the malpractice provision, among others. The PRC presented several points regarding the proposed bill and emphasized that the training, accreditation and certification of specialists should remain with the specialty society, with government oversight by the PRC as it is currently being practiced. There were no objections from the floor regarding this provision.

After lengthy discussions between several congressmen, the PMA, the PRC, with input from the DOH, a motion was put forward and carried to create a Technical Working Group. This will be headed by Rep. Janette Garin to consolidate the discussed bills and formulate a final form of the Physician's Act to replace RA 2382 known as the Medical Act of 1959. It was announced, too, that this was the final hearing regarding the bill and henceforth, it would be the TWG that would be working.

Personally, I think it was a battle half won. The PCS had been working in the background for the Physician's Act. It was a long 5-year journey. The fact that we were invited to the Congress meant that indeed, the PCS was making a difference. The next hurdle is the TWG, and hopefully all suggestions will be remembered and put into the law. And if made into the law, next to be considered is the IRR – implementing rules and regulations of the law. As for now, we will face our battles as they come.

Earlier on the morning of March 22, 2023, I took a picture of Dr. Lim and myself in the vehicle as we made our way to Batasan. I sent the picture to our Regents' Viber group with a caption "for the country and future doctors." There is a well-known coffee advertisement that asks, "Para kanino ka bumabangon?" It goes on and asks, "Para sa sarili? Para sa pamilya? Para sa iyong mga minamahal? Para sa mga kaibigan? Para sa iyong trabaho?"

1st BOARD OF REGENTS MEETING January 21, 2023 (Saturday); 8:00 am - 2:30 pm GT Singian Board Room, PCS Building, 992 EDSA, QC

The meeting was called to order at 10:50 AM with Dr. MCC Vesagas presiding followed by an Invocation led by Dr. DS Aison . The adoption of the Agenda was APPROVED, with the inclusion of the item on a Fellow's concern with Serious MD under "Other Matters".

Dr. CCVesagas, PCS President, welcomed the Regents to the 1st Board of Regents meeting. She mentioned the continuation of projects/activities conducted in 2022, particularly the simultaneous surgical missions, eFAP program and the focused practice designation, among others.

She also reminded the 2023 Regents of their Duties & Responsibilities. All Regents were provided copies of the Regents' Duties and Responsibilities.

PRESIDENT'S UPDATE

1. PMA Meeting - January 13, 2023 - Re: Physicians Act

The PMA scheduled a meeting last January 13, 2023, regarding the Physicians Act. In attendance was Dr. George G. Lim, Chair, Adhoc Com. on Physicians Act together with PRC and four (4) Congressmen (Gato, Miguel, Golez, Tan).

An update will be given next meeting. Meanwhile a meeting with the Presidents of the specialty divisions and PMA will be scheduled.

2 Nursing Law

As discussed last year, the proposed Nursing Law, particularly the extent and limitations on the practice of nursing, was in question. The PMA is currently reviewing this.



3. PCS Motorcycle

The BOR approved the purchase of a motorcycle and helmet for the PCS messenger . The PCS Building Committee was then tasked to come up with the guidelines on the use of the motorcycle

4 AED Proposal

The BOR approved the purchase of an Automated External Defibrillators (AED) including an ambu bag for use in the College. The PCS staff will be trained on its usage, and these equipment will be brought during official events.

TREASURER'S REPORT

Dr. JRC DeLeon reported on the current financial status of the PCS funds including fund placements. Update on Delinquent Fellows (279) showed 51 Fellows settled their arrears (14%).

Since eFAP launch last December 2022, a total of six (6) Fellows have so far subscribed to the program. All Regents were encouraged to subscribe and disseminate such program.

COMMITTEE ON CONVENTIONS

Post-convention evaluation of the 78th Annual Clinical Congress last December 4-7, 2022 at the EDSA Shangri-La Hotel was discussed and problems encountered were offered remedies.

The Orientation of New PCS Inductees was held at the Convention site unlike previous years when it was held outside . This was noted by the BOR to be more convenient and effective and will continue there on.

The BOR also noted the big role of Docquity in monitoring attendance during sessions but will also look into borrowing PMA RFID gadgets for future conventions.

The committee will also formulate policies and guidelines as regards use of the Learning Centers.

For the upcoming 49th Midyear Convention with the theme: "SURGERY AND UNIVERSAL HEALTHCARE" to be held on May 4-5, 2023 at the SMX Convention Center Lanang, Davao, the Committee is in ongoing discussions with the PCS Davao-Southern Minadanao Chapter on the details for the preparation. The BOR also approved the proposed registration fees for Convention attendees and Sponsorship packages including the Learning stations. Also, the UHC Summit and the PCS-PALES-ORNAP MIS Workshop will be held in conjunction with the 49th MYC 2023. For the 79th Annual Clinical Congress on December 3-6, 2023 at the Edsa Shangri-La Hotel with the theme: "COLLABORATIONS AND INNOVATIONS IN THE ERA OF GLOBAL SURGERY, the BOR approved the Proposed Registration Fees and the Joint Convention with the ASA (Asian Surgical Association).

COMMITTEE ON SURGICAL EDUCATION

The BOR approved the free registration of the Lay Forum stakeholders during the 49th Midyear Convention on May 4-5, 2023, at SMX Convention Center Davao. Attendees to the Lay forum will be issued ID badges in advance.

Suggested topics for the 79th ACC were also noted by the BOR with additional instructions to the committee to invite a speaker from IRCAD who can lecture on choledochoscopy and CBD as a pre-convention session and Dr. Gustavo Matthews also as a speaker.

The Committee also informed the BOR that the total number of attendees to the 78th ACC last December 4-7, 2022 was 2368. Certificates of Attendance with CPD units (16) were already sent to respective participants.

As regards Primary Care Surgery, follow up of edited chapters for the Primary Care Manual is being done, target is to launch it during the PAFP Midyear Convention. Presentation of new guidelines will be done in the annual convention of PAFP (March). Also, coordination with PAFP regarding the schedule of symposia to be conducted for this year.

For the Sub-committee on Webinar, coordination with surgical specialties on their scheduled webinars is being done.

 - a) DOST Letter from Dr. Jaime C Montoya Re: Research Study on "Cost Estimation of PhilHealth's Case Rates and Determination of Cost-sharing Schemes"

Dr. Montoya informed the College that the research study has been postponed until further notice from PhilHealth, who is funding said study.

Board Action: The PCS will pursue said study since the Committee has an allotted budget of Php1.5 M.

Treasurer's Report

8.1. Dr. JRC De Leon reported on the current financial status and investments of the College. The Board APPROVED withdrawing the investment with AXA Philippines (Chinese Tycoon) and Insular Life Assurance once said investments mature and returning them to the College's coffers. The Committee on Finance will study where to invest the said money with better returns.

Board of Governors

The Board noted the Composition of the 2023 Board of Governors with Dr. Jorge M. Concepcion, as Chairman

Committee Reports

9.1. Cluster E – Socio-economic Matters

a) FINANCE COMMITTEE

The BOR noted the the Composition of 2023 Finance Committee members including tasks in setting up the e-FAP, (Expanded Fellows Assistance Plan) - an in-house program of the PCS designed to provide better benefits than other HMOs and at a lesser cost. Later, this will include provisions for Calamity or loan benefits. The program is ongoing and subscription to the program is being accepted thru the PCS Secretariat.

In cases where decisions must be made immediately particularly in transferring placements with higher yield/ interest rate, the Board APPROVED that this be brought to the attention of the Executive Committee for faster and prompt resolution/decision.

- Real estate investment outside Metro Manila. Interested Chapters can look for lots for sale- even, a 500 sqm. property and construct a building. This will encourage various PCS Chapters to be more active.
- The Finance Committee should be engaged in the preparation for the Annual Convention together with the Convention Committee to study the packages to give.
- Mr. JP Casas (PCS Financial Adviser) will conduct a Face to Face Financial seminar for our Fellows on the second half of this year.

b) PCS BUILDING COMMITTEE

The BOR approved the contract renewal of all tenants of the PCS building with corresponding yearly excalation of rental fees as proposed by the Committee.

The BOR recommended further study by the Committee regarding options for increasing Internet Connection speed in the building as a faster net connection is needed for the LMS program.

Guidelines for the use of the PCS acquired motorcycle plus the daily Route Form and purchasing of a motorcycle compartment were also approved by the BOR.

Upon proper review of the proposals submitted, considering the same specifications and brands of materials to use, the BOR approved the Committee's proposal to:

Philippine National Cancer Summit Calls for Urgent, Collaborative Actions to Bridge Gaps in Cancer Care

February 28, 2023 - OVER 1,500 healthcare professionals, cancer patients, and business leaders gathered at the Philippine National Cancer Summit (PNCS) last Feb. 23-24, calling for a whole-of-society approach to advance the cancer care system in the country.

Held in line with the National Cancer Awareness Month, the Summit, organized by the Philippine College of Surgeons Cancer Commission Foundation (PCS CanCom), together with the Philippine Cancer Society and Cancer Coalition Philippines, brought together advocates and prime movers in the medical community, patient and survivor groups, academic and research institutions, industry partners, private sector, local government units, and key national stakeholders.

PCS CanCom Chairman Dr. Manuel Francisco T. Roxas said PNCS provided an opportunity to discuss how various sectors can communicate, complement, and collaborate to bridge gaps in cancer care, including the lack of accessible financing opportunities for cancer patients and siloed approach in addressing cancer. The two-day summit featured indepth discussions for patients, healthcare providers, healthcare professionals, and finance and private industries.



"Through it all, we learned how important it was for us medical practitioners to listen to patients and to see their struggles with cancer beyond the clinics," Roxas said. "For this Summit, we wanted the participants to go home with a clearer understanding that comprehensive cancer care requires a whole-of-society approach. That each one of us has a role to play in the implementation of a truly working NICCA."

PNCS built on the impending implementation of the National Integrated Cancer Control Act (NICCA), which aims to boost cancer control efforts, improve survivorship and reduce burden to Filipino patients and carers. NICCA was signed into law following lobbying efforts led by the Cancer Coalition Philippines, supported by patient organizations.

Among the promises of NICCA is the establishment of Cancer Assistance Fund, which will provide financial

assistance for the screening, diagnosis, treatment, and rehabilitation of financially-challenged patients, and the expansion of benefits for cancer patients under PhilHealth.

Kara Magsanoc-Alikpala, founding president of ICanServe Foundation and vice president for internal affairs at Cancer Coalition Foundation, said despite challenges and delays in NICCA's full implementation, efforts that led to the signing of the law are examples of collaboration that will provide inclusive and integrated services for Filipino cancer patients.

"If we don't collaborate, we will always be stuck with pilot projects that will never scale. We have to map everyone's initiatives and see how they are all connected. The more private and public groups collaborate, the wider and bigger the impact," said Magsanoc-Alikpala, who also serves as a director at PCS CanCom. "We must step on the gas. No time for excuses."

In a video message, Vice President Sara Duterte said "our collaborative efforts are important in ensuring better access to quality cancer care, especially to our kababayans who are unable to afford it." Vice President Duterte also emphasized that a whole-of-society approach can lead to the development of new and better ways to address cancer and its impact to Filipino families.

Meanwhile, Health Undersecretary and OIC Dr. Maria Rosario S. Vergeire said the Department of Health will continue to implement programs to attain affordable and accessible services for cancer patients "through public awareness and people-centered care."

Cancer is now the third leading cause of death in the country with over 153,000 new cases and 254 deaths reported every day. Breast, lung, and colorectal cancers are the top three cancer incidences, while lung cancer ranks first in mortality.



The 78th Annual Clinical Congress Quality Surgery For All



At present, all the professional surgical fees paid for by these HMOs are based on the 2009 RVS(Relative Value Scale) Manual.

In 2020, the PCS Committee on HMO under the leadership of Dr Fernando Lopez (Chairman on Committee on HMO) and Dr Joselito Mendoza (PCS Regent-in charge) updated and revised the 2009 RVS using the 2015 Modified Scheme based on a point system devised by all representatives of each specialty society under the PCS. This was used in scientifically computing for the relative value units (RVUs) thus increasing the RVUs of each procedure from different cutting specialties. New procedures especially breast and laparoscopic cases were also included in this Revised RVS of 2020.

The revised Manual was presented to AHMOPI and PAHMOC in 2020. Initially, one group was receptive to the revision but eventually, both PAHMOC and AHMOPI held the proposal at bay because of the pandemic. They also argued that their clients have already been made to understand in their contracts with the HMOs, that the surgical fees are fixed which are based on the existing 2009 Manual. Changing the rates in the midst of their contracts and with their customers having paid only a certain premium, would mean losses for the HMOs.

The Committee proposed to the HMO groups that the revised RVS manual be applied only to the 20 most common general surgical procedures and the most common surgical procedures of other surgical specialties. These procedures will have multipliers from at least 50-100. Expectedly, both could not agree on the multiplier. The committee proposed the higher multiplier but the HMO groups wanted the lower one.

At a certain point, the committee decided to conduct a survey involving all Fellows of PCS to ask if they would approve that the PCS Board of Regents insists to the two HMO groups that they adopt the revised 2020 Manual of RVS. The result showed an overwhelming approval from the Fellows. However, this did not materialize because of the arguments presented by the HMOs in relation to the PCS proposal. We are at a deadlock. Last year, 2022, the committee negotiated with the HMOs and Fellows who signed the Universal Service Agreement (USA) entered into a MOA where the multiplier for RVS cases was increased by 15 points but still using the 2009 RVS. So ward cases now have a multiplier of 135 from 120 and suite rooms from 140 to 155. Additional benefits are the retention of the Php 600 consultation fees which expired for non-PCS Fellows since the easing of the pandemic, and a corresponding Php 100-150 increase of daily rounds fees for admitted, non-operated surgical patients.

Take note that all Fellows must have signed the new Universal Service Agreement (USA) starting 2022 onwards in order to avail this 15 point increase in the multiplier and other benefits Those who have signed in 2020 and 2021 are already invalidated.

In one of the recent dialogues between the committee and the President of all the HMOs, the proposal to adopt the Revised 2020 RVUs was again raised. However, the counter argument of the HMOs was that, if the Revised 2020 Manual is approved by the Philippine Health Insurance Company (PHIC), only then will they agree in applying it to the different surgical procedures.

The PCS Committee furnished a copy of the revised 2020 Manual of RVUs to Philippine Health Insurance Company (PHIC) for consideration, However, PHIC was quite indifferent in acting on the proposal because of their already existing case rates. The assigned RVS units do not apply to PHIC anymore. With this predicament, we are being pushed to the wall.

With the Universal Health Care Law, Philhealth is now gearing towards Disease-Related Groupings and is now shifting from RVS to ICD codes. Philhealth is also reminding us on its guidelines on enterolysis. The Memorandum on Medical Evaluation Guide on Claims for Enterolysis as Primary or Secondary Procedure Annex J of March 7, 2011 states that enterolysis, defined as surgical division of intestinal adhesions with RVS code of 44005 and RVU of 450 shall only apply to severe adhesions and/or with concomitant sign and symptoms of intestinal obstruction under the following conditions:

1. Enterolysis is the primary procedure performed (e.g. Enterolysis for intestinal obstruction due to post-operative adhesions)

- a. Final diagnosis in the operative record should indicate previous history of surgery if present (e.g. intestinal obstruction due to post operative adhesions).
- b. Description on the extent of adhesions should be stated in the operating room record(e.g. generalized adhesions involving majority of small intestines).
- 2. Adhesiolysis/Enterolysis is performed as a secondary procedure (e.g. Total Abdominal Hysterectomy RVU 200) with incidental findings of severe adhesions involving the sigmoid colon due to endometriosis) when any of the following are present:
 - a. Multiple, dense and severe adhesions (more than one quadrant)
 - b. Adhesions cover the primary site (ovarian malignancy covered by intestinal adhesions
 - c. The procedure adds considerable time to the operative procedure by at least two (2) hours from the usual duration of the operation of the primary procedure; and,
 - d. Increased risk of morbidity and mortality to the patient (patient developed significant hypotension or blood loss during surgery)

The intra-operative findings that required the performance of enterolysis should be reflected in the OR record (e.g. severe adhesions covering the sigmoid colon). Health care providers may be requested to submit claim Form 3 or Clinical abstract if necessary for the evaluation of claims for Enterolysis (RVS44005) by Philhealth Regional Offices-Benefit Administration Section (along with the operative room technique when data in the OR record does not sufficiently reflect the above mentioned criteria).

Last month, the Committee met with the leadership of AHMOPI to possibly adopt the 2022 RVS for 2023. Salient points were explained and AHMOPI seemed receptive to our request. Lets just keep our fingers cross for a positive outcome.

Rest assured that the PCS Committee on HMO is doing its best in prioritizing the welfare of each Fellow from different cutting specialties. Let us remember that the HMOs are here to stay. But the Committee will continue to engage with them with the best interests of our fellows, our utmost concern.

Forever Young

"Doc, kung ikaw po ba nasa lagay ko, sa edad ko, magpapagamot ka pa ba or eenjoy mo nalang anong oras natitira sayo?" This was the most baffling question that was ever asked of me by a patient. For someone who speaks fast and answers queries rather confidently, this question was met with a 10 second silence followed by a soft sigh. I know I had to answer in a professional manner and give the patient the advantages of what going thru the complete treatment could entail for her health and that's what I did. I said yes after the 10 second silence but in all honesty, the mind lag was me thinking of the perfect way how to tell and convince her what I was trained to do as a medical professional.

My patient is an elderly patient, who, in her early 70s, presented with no comorbidities and is still very active for her age. She had a very big mass on her left breast and when I say big, it could be the queen of all the T4 tumors. It has been there for about a year and out of fear, she purposely did not seek any medical help up until it was causing her grave discomfort and she has come to terms that it could be malignant. I performed a core needle biopsy and true enough, it was Invasive Ductal Carcinoma. When I broke the news to her, she was surprisingly very calm as if she already knew it way before I even read the report. It was the look of someone who already know what to expect and has accepted it and just needs someone to read her the official report and confirm what she already knew all along. I then referred her to a medical oncologist after receiving the rest of the breast panel results and other laboratories for neoadjuvant treatment and she was then advised to undergo the necessary neoadjuvant treatment with plans of surgery after. She came back to my clinic after meeting with the oncologist and told me that she's refusing to do anything as of the moment. She said that she came back to my clinic just to thank me personally for giving her the courage to go through with the biopsy.

"Bakit naman po mommy, sayang naman po maaga pa para mag give up kayo kasi kayang kaya po yan."

And then she gave me that answer to which I was dumbfounded. She then went on to say that she

will just use her money to travel with her family and create better memories than spend it on something that will create morbid memories of her undergoing chemotherapy and radiotherapy. She said that she has a lot of grandkids that she seldom sees and that she would love it if she can start spending more time with them and visiting them abroad and bring them to Disneyland so they can remember her fondly as the fun and cool lola and not the sick lola. Her answer tapped on the non medical side of me. It gave me a pinch of reality check that if I was in her shoes, I probably would also not follow my own advice and make the most out of my remaining days like what she would do, because let's face it, her plan is very appealing as well. I would imagine doing the things that I never did with the people I love most and visiting the places that's on my bucket list creating wonderful memories before I go. We all know how tedious and tiring going thru the sessions are and though we are experts on that field, it makes it easier for us to recommend and advise it because we are not the ones getting the treatments. If we are also diagnosed at that age, most of us would probably think of the same thing even if we are too ashamed to admit it.

Just like any other surgeon, decisions by patients such as this really gives me a big dose of disappointment. I'm sure a lot of us think that those who refuse the treatments who have the means to do so have a little cowardly shadow lurking behind them. For me, knowing is better than not knowing because you can always do something about it and I am always a firm believer that the unknown enemy is more terrifying than anything else. Knowing what you have equips you with the opportunity to face it headstrong because you know what you are dealing with and you have been given the gift of knowing how to win your battle. I was frustrated with her decision because to me it felt like she was giving up even before she starts the war.

Part of knowing that you are battling something is mustering up the courage to stare at fear in its face and giving it a run for its money. But after hearing her reasons, I know I can only do so much and that I have given her all the information that she needed to be able to come up with a conformed decision. And if her decision is to go with her plan, then as her doctor, I need to respect her decision and wish her the best and give her the assurance that if she changes her mind, all her doctors are just standing by for her. She left my clinic teary eyed and expressed gratitude again for everything that I have done for her and that was the last time that I heard of her.

After some time, her reason gave me a new understanding about courage and strength. My initial thought is that she probably is not a strong person to be able to handle her disease and everything that came along with it. But after contemplating and trying to understand her decision, I came up with the realization that is she is far stronger and fearless that I gave her credit for. At first, it seemed that she rejected the possibility of a cure and to some it may seem like it's a type of failure on that person's part. After hearing her reason, I now view her rejection not as a failure.

Failure is giving up entirely. Everyone gets rejected somehow and it's how they handle it that determines where they will end up. Her decision was not based on her giving up, but it was based on her accepting the possibilities that lie ahead and refusing to be defeated by fear and still live her best life. She accepted her diagnosis and embraced it for what it is, and knowing what little time her age could still offer her, she chose to step away from her worries and live life to the fullest despite those trepidations. For fear does not stop death but it can stop our lives if we chose to be swallowed by it. She gave me a new meaning of what being strong should be and that courage comes in a lot of forms. It takes a lot of it to let something go than to hang on to it. In her case, her letting go did not mean that she was ignoring her situation nor was she in denial of it. She accepted what it is, exactly as it is, without fear. And coming up with a plan that she thinks would make her life more meaningful and making the most out of it. It made me appreciate her more and thank God that from time to time, He gives us patients that teach us new things that no books nor journals could ever do.

I still hope that I get to see her one of these days even if it means just to check up on her and if she crossed off a lot of things from her bucket list including her much awaited Disneyland trip, because of course, why not? As Walt Disney once said, growing old is mandatory but growing up is optional. And if she will be remembered fondly by her grandkids, that would be a new item on my bucketlist as well and live forever young in the hearts of those I will leave behind. Our patients show us gratitude most of the time but let's not forget to give them back the same gratitude that they bestow upon us because for all we know, they could be teaching us important life lessons along the way. To end my piece I would like to share a line from a poem by Charles Bukowski:

> "We are here to laugh at the odds and live our lives so well that death will tremble to take us"



I wish to thank the department chairperson, Dr. Ida Lim for the invite. It is both a pleasure and an honor to be your graduation speaker. This is a homecoming for me ever since I finished my surgical residency in this institution more than 25 years ago. I was privileged to have Dr Alex Erasmo your immediate past chairman as my Training Officer when I graduated as Chief Resident in 1994. .Dr Robert Domingo -thank you for the kind introduction. Dr Domingo was the chief resident when I was a budding first year resident. One of my assignments from the chief was the regular changing of the bed sheets and cleaning of the surgery quarters located at the rear end of the operating room complex. Time flies.

In the book, *The Making of a Surgeon*, the author's father, a lawyer, said to his son: "Bill if you are smart, when you grow up, you will be a doctor, those bastards have it made! "Dr. Bill Nolen became a doctor, a surgeon. He went through general surgery residency training at Bellevue Hospital in New York, a hospital recently made popular by the Netflix series New Amsterdam. Dr Nolen underwent rigorous training in general surgery, later becoming Chief Resident and Department Chair and assumed other prestigious positions. Indeed, he had it made.

Part One

GREAT EXPECTATIONS

Becoming a surgeon does not happen overnight, the neophyte goes through an extremely difficult process to be a surgeon. The journey begins when the worthy "one" is awarded a hard to get slot in a medical school where acceptance, means that you have labored to achieve sobresaliente grades, aced the medical school qualifying examination and like the Dr Nolen -have affluent parents (a lawyer) who will fund your tuition fee, allowances, dormitory or condominium accommodation , books and gadgets. After these four years of diligent study, the would be surgeon graduates as a Doctor of Medicine. A year in internship prepares the doctor to become a full pledged physician but only after passing a grueling four day physicians licensure examination mind you Last October, only 5,958 examinees (64%) passed the PLE by the PRC.

The journey continues when the novice has to vie for very limited vacancy position in a selected residency surgery program. I remember during our time that only four new residents were accepted out of the more than eighty applicants. Jose R. Reyes Memorial Hospital has been one of the preferred institutions because of the patient load, clinical material, renowned mentors and variety of cases, conditions which are ideal for training. Bonus and salary in government hospitals are additional perks compared to the dismal remuneration for our counterparts in the private hospitals receive.

The present structured surgery training program is fashioned after a model by the great William Halstead. It is charecterized by a gradual progression of responsibility and functions in a multitier set up, this has replaced the traditional apprentice type model. The five-year PSGS surgical curriculum following this model. consists of 45 months rotation in general surgery and 15 months rotation in the subspecialties. This is guaranteed to mold the trainee into a well rounded surgeon. Regular preoperative and postoperative, morbidity/ mortality, tumor board, journal clubs conferences are the required didactics.

The meeting of the minds at Fe Del Mundo Hall are experiences one never forgets. In front of the consultants, interns and clerks, you are tasked to present and discuss cases. You better be prepared to answer the most intimidating questions from the "insultants" otherwise you open yourself to criticism and ridicule. There are lessons learned here. These encounters are not meant to bring you down but to push you up... Later, you will realize the question and answer, probing and interrogation you get are very important not only when you take the diplomate examinations but more important is when you are handling your private patients. The gems of wisdom imparted to you will always come in handy and you will be glad you went through these "trying"times.

Aside from the conferences, research output is mandatory. Dr Alex used to caution us that if you copy from one author that is plagiarism but if you copy from several authors that is research! Seriously, in most competitive fellowship programs, research output is the deciding edge for admission. Published research are eye catching details of your CV.

I noted during the residents party that your residents have presented at the American College of Surgeon's Convention, way to go, so good, congratulations!

Duties, operations, conferences, research what more?

Every year the surgical resident is expected to perform well in the CERES and the RITE as basis of promotion and gauge of learning of the trainee. When I was a second year resident and on the early morning of the scheduled RITE, I did an emergency close tube thoracostomy on a stab wound patient. The tube output was around 500 cc, this was around 3 am and my seniors and me were busy cramming for the examination. At the ward, I released the tube clamp and another 300 cc of blood was drained. Alanganin timing since our team knew for a fact that if we do the thoracotomy we will not be ready for the RITE scheduled at 8 am at the Makati Med. At 6 am, Dr Alberto Roxas arrived and we endorsed the patient to him. He was our training officer at the time and required all residents to take the examination, reason why the consultants go on duty during the RITE. On the way out, I saw Dr. Alberto Roxas personally driving the patient on a wheelchair stat to the operating room.

Inspired by his heroic gesture, we garnered 90 percentile ranking in the RITE. During the post op conference when the case was discussed, I remember Dr Roxas saying how he missed the operations during his days of residency. As you can see, a lot is expected from the trainee. This discipline requires sacrifice, skill, always thinking and deciding, being tough physically and mentally.

The adrenaline rush and feeling of excitement of your first appendectomy, the sadness of an anastomotic leak morbidity, problematic patients and sleepless nights hound you. Uncertainties and frustrations abound. Bowel sounds and farts have become music to the ears.

I vividly remember a multiple stab wound patient who I operated and did a colostomy. Despite numerous attempts to construct a pouty ostomy somehow, I miserably failed. As expected there was a problem fitting the colostomy bag and secretions would leak on the sides. I monitored this problematic patient and personally changed the ostomy bag prn. I hid patient in the far end of the ward so that my seniors wouldn't notice. I prayed that the abdominal distension would lessen and probably the ostomy would pout and improve. I was so embarrassed and scared when the patient later transferred to UST as a private patient of Dr. Erasmo I remembered hiding from and avoiding Dr. Erasmo for at least two weeks. Another instance I cannot forget is during my rotation in neurosurgery, when in trying to impress Dr Rafael our charismatic and enigmatic neurosurgeon, I made a positive film of a contrast carotid angiogram of a brain injury patient. I proudly showed him the plates, he examined it and asked who did it? I said I made it and I even suggested that he use it for his teaching class. Dr Rafael was strangely quiet during our rounds. Assuming I scored some pogi points, I accompanied him back to his car. Before he shut the door he whispered " you are still stupid". And suddenly, we are business as usual. Dr Armand Crisostomo assisted me on my first case of hernia Lichtenstein repair, and seeing my hesitation, he patiently coached me and later remarked -bilisan mo na Bob, manonood pa ako ng NBA !. I am, you are, we are forever grateful to OUR dedicated mentors.

All in all, the surgeon devotes at least 27 years para magpakadalubhasa na isang surihano. (this does not include sub specialties and super specialty training). That is one third of his lifetime considering that the average life span of a Filipino is 75 years ! Surgical education is non-stop!

ADVISE TO YOUNG SURGEONS, KUDOS and GODSPEED!

It is said that a difficult road often leads to a beautiful destination. A full pledged Fellow -Surgeon has its rewards. For instance at Mother Seton Hospital where I am medical director for the last twelve years and chair of the credentials committee, specialists who are board certified are welcomed to apply, stocks and hospital shares are not required. Similarly in Bicol Medical Center a government hospital in Naga City and the biggest hospital in the region, which offers medical specialist positions only to Board certified applicants. Medical Specialist II entry level with a decent salary grade is not bad, enough to cover expenses for your young family, car amortization, utilities and clinic rent.

After Surgery residency, you come to realize that you are starting all over again. You have the option of going to sub specialty or immediately engage in private practice. Many chose to go to the first option of additional training like what I did, I took an extra fellowship in head and neck surgery, the extra experience is a distinct advantage. Or you may decide to go to private practice right away.

That is fine too -you have a head start over your batchmates and perhaps get the latest model of Honda Civic faster- both literally and figuratively. Whatever your choice is, persevere and exert your best effort and you will be surely rewarded.

My ten cent worth of advice, make your services affordable and short of being frugal, live within your means. Don't fall in the trap of ordering everything you see in lazada and then maxing your credit card. This may lead you to unfairly overcharging your patients, lose loyal patients and may turn off potential clients. Develop your patient base, they are your endless source of referrals. Always be cordial and courteous with your colleagues.

Congratulations to the program, to the department chair, training officer and the rest of the faculty, you are very true with your Mission and 20/20 or clear with your vision.

Congratulations to the trainors and trainees.

To the family of the graduates, you are equally congratulated and commended for the support and understanding you have given to guarantee the success of these residents.





History of Neurological Surgery in the Philippines

The first recorded neurosurgical operation in the Philippines dates back to 1878 and was the neurosurgical procedure of trephination. It was written in a "Program of Operations", a document found in the archives of the Faculty of Medicine and Surgery (established in 1871) at the University of Santo Tomas, the oldest existing university in Asia which was founded by Royal Decree by the King of Spain in 1611.¹

Pre- Second World War

The cranial operations at this point in time were mainly neurotrauma cases done by general surgeons who had the opportunity to observe and train in the United States. Such was the case as Dr. Jose Ignacio V. Abuel, a general surgeon who further studied Neurosurgery at Harvard from 1923 to 1925 performed the first craniotomy for the evacuation of a subdural hematoma in 1928 at the Philippine General Hospital. Dr. Abuel was the first Filipino neurosurgeon to introduce ventriculography as a diagnostic tool and also brought home the technique of pneumoencephalography to localize intracranial lesions.⁴

In the 1930's, Andres T. Zavalla, another general surgeon went to train in Neurosurgery under Dr. Walter Dandy at the Johns Hopkins Hospital in Baltimore.

He came home and performed the first craniotomy for the excision of brain tumor in the country in 1941.²

Post Second World War

The Philippines started to have modern neurological surgery after WW II when the United States Army established the 4th General Hospital at Fort William McKinley (now Fort Andres Bonifacio). Col. Fritz Cramer, from the New York Neurological Institute and a US Army consultant in neurosurgery for the Far East established a section in Neurological Surgery at this hospital. Dr. Romeo H. Gustilo, a young medical officer in the Philippine Army had the opportunity to get exposed to neurosurgical work treating war injuries in this institution. This led him to pursue neurosurgical residency training under the tutelage of Dr A. Earl Walker at the Johns Hopkins Hospital until 1950.¹

Dr. Victor A. Reyes, a surgical resident under Dr. Zavalla at the Philippine General Hospital (PGH) got inspired and went for further neurosurgical training in 1946.

He was mentored by Michael Scott Sr. at University of Pennsylvania, Gilbert Horrax at Lahey Clinic in Boston and Wilder Penfield at the Montreal Neurological Institute in Canada. After completing five years in residency, he became the first Asian to be certified by the American Board of Neurological Surgery in 1951.²

Dr. Howard Naffziger, a US Army senior consultant for neurosurgery in the Far East did the first cerebral angiogram at the University of Santo Tomas Hospital during his multiple visits to the Philippines between 1947-1948.¹

The first section of neurological surgery in the Philippines was established in the Department of Surgery, Santo Tomas University Hospital in 1950 followed by another one at the North General Hospital (now Jose R. Reyes Memorial Hospital) just a few months after. Both sections were chaired by Dr. Romeo H. Gustilo. Upon his return to the Philippines in 1952, Dr. Victor Reyes also established the section of neurological surgery at the Philippine General Hospital. This was followed by the establishment of a section also at the Armed Forces of the Philippines by Dr. Melchor Javier in 1954.¹

The first locally trained neurosurgeon in the Philippines was Dr. Faustino Domingo Jr. who finished in 1959 under the mentorship of Dr. Victor Reyes.³ He went for further training in Neurology at the University of Wisconsin with Dr. Francis Forster and at the Lahey Clinic under Dr. James Poppen.²

In 1961, 8 neurosurgeons, mostly newly returned from training in the USA, founded the Philippine Society of Neurological Surgeons (PSNS) with the aim to develop more training programs in neurosurgery, establish accreditation boards and promote quality neurosurgical care in the Philippines. The founding members were Drs. Homobono Aldaba, BenignoAldana, Roger Baisas, Henry Cube, Romeo Gustilo, Melchor Javier, Victor Reyes and Mariano Torres.¹

The Philippines is the first country to have a neurosurgery service in Southeast Asia.⁵

In the 1960's, Dr. Leopoldo Pardo Jr. who trained at Baylor University is credited to have done the first transsphenoidal surgery for pituitary adenoma in the country. He was part of the neurosurgery section of the PGH.³

The PSNS was able to publish a local scientific journal in 1965. As the society continued to accept more fellows, they sought to establish criteria to be able to promote neurosurgical education for future trainees. The Philippine Board of Neurological Surgery was founded in 1975 with Dr. Romeo Gustilo as the Chair and Dr. Victor Reyes and Dr. Renato Sibayan as the other two board members.

The PSNS started to host international conventions. Dr. Gustilo was a founding member of the Asian Australasian Society of Neurological Surgeons (AASNS) which was established in 1967. Under his leadership both as President of the AASNS and as Congress Chair of the Asian Australasian Congress of Neurological Surgery (AACNS), the PSNS hosted the 5th AACNS in Manila at the Philippine International Convention Center on November, 1979.

In 1976, the first formal structured neurosurgery training program was started at the University of the Philippines- Philippine General Hospital. Mentors included Dr. Roel Romero as Division Chief, Drs. Ramon Suter, Renato Sibayan, Victor Reyes and Faustino Domingo Jr. Dr. Camellia N. Posoncuy, the first Filipina neurosurgeon who trained in Switzerland under Professor Gazi Yasargil joined the faculty as soon as she returned to the Philippines. The first resident graduates of the UP PGH training were Drs Norman Bitanga and Antonio Rafael.²

In 1999, the PSNS evolved into the Academy of Filipino Neurosurgeons, Inc. (AFNI) which is the present society of board-certified neurosurgeons in the Philippines.

The Philippines has 142 fellows of the AFNI though there are already 212 graduates of 10 training institutions for Neurosurgery. They are distributed all throughout the country but some areas are still underserved. The ratio is 1:800,000 population at this time and the future of Neurosurgery in the Philippines is still getting brighter.

The Time has Come for the Philippine Surgical Infection Society

It is not common knowledge, but the seminal events leading to the creation of the Philippine Surgical Infection Society were set in motion in 2016 by erstwhile PCS president, Dr. Gabriel Martinez. An invitation came for a representative from PCS to participate in talks on developing a Surgical Infection Society in the Asia Pacific, to complement similar organizations in Europe and in North America. Dr. Esther Saguil, who was then PCS Chair of the Committee on Surgical Infections was enjoined to explore the potential of the collaboration, with meetings held with Asian counterparts. It became evident that to be an effective participant in the SIS-AP, as the organization was called, the Philippines had to organize one to lead efforts in infection prevention and control in the surgical arena. It was a surprise to the other delegates in the SIS AP meeting that the Philippine participants shared the same passion in finding practical, effective, and efficient ways of preventing surgical site infections such as promoting the antibiotic stewardship, encouraging the use of prophylactic antibiotics, not to mention the promotion of proper hand washing and skin preparation. It was only a matter of time that a society dedicated to infections in surgery would come into fruition.

The development seemed slow, as there was still some hesitation even among the surgeons as to its role in the general scheme of things. Was a separate society really needed, or could the individual affiliate society take on the infectious aspects of surgical care? However, the persistence and perseverance, the efforts have paid off, as other organizations concerned with infection prevention and control (IPC) who had always considered the operating room as the last frontier, welcomed champions among surgeons. Finally, surgeons were REALLY involved.

The creation of the PSIS had its champions within the PCS too, notably the Presidents and Regents who whole-heartedly supported the endeavors. The Society, which was officially registered with the Securities and Exchange Commission in 2018, is a non-stock non-profit organization that envisions a unity of purpose – get the surgeons, nurses, infectious disease specialists, and other stakeholders to rally in reduction of infections in surgery through implementation of guidelines and protocols. The Covid pandemic certainly placed IPC in the spotlight, and the role of the PSIS was further cemented in operating rooms nationwide.

The shining moment of PSIS came in the form of former President Rodrigo Roa Duterte's Executive Order Number 971, otherwise known as the Creation of the Surgical Infection Prevention Awareness (SIPA) day in June 23, 2020. SIPA Day, which is celebrated every second Saturday of July, aims to remind everyone of the need to prevent infections in surgery, ensure quality outcomes, and prevent increasing antimicrobial resistance. This year, the Society was officially welcomed as an affiliate society of the PCS. Truly, a momentous occasion that validates all the years of efforts and spurs us to further pursue our advocacy in every corner of the country.

We, in PSIS, have realized early on that we are not alone in this fight against surgical infection. We welcome members - stakeholders in surgery, whose main qualification is a desire to keep surgery safe and infection- free, and a commitment to educate those in the medical profession and the public about surgical infection – its prevention and management. We also hope to generate data on infectious complications to further provide guidance on our next steps in mitigation of surgical infection.

Join us in our quest to keep infections at bay. We look forward to working with CHAMPIONS.

Getting More and Giving More

When you have more of something, you'll have more to share to others.


This year, the Philippine Orthopedic Association has given this phrase an interesting twist with a deeper impact and significance.

More than the usual "getting more training, education, and opportunities for advancement" for its members, and for society in general, the POA has set its sights this 2023 on "getting more involved in national health policies". Having a good grasp of the details of the laws and its implementing rules and regulations will allow better planning and utilization of resources by stakeholders, including orthopedic surgeons. Specific laws in mind are the Universal Health Care Law and the proposed Physician's Act of 2023.

The POA started the year with an orientation of both legislations for its fellows, given by members of the staff of lawmakers together with lead government agency representatives involved in its creation and implementation. How will these affect my orthopedic practice? What is expected from me? How can I help in its implementation? These are just a few of the questions expounded and given clarity during the activity.

At the same time, workshops and town-hall type discussions with PhilHealth were conducted related to the transition from an All-Case Rate system of reimbursement to a Diagnosis Related Grouping





method. All these activities were meant to maximize insurance fund utilization and improve access to treatment for Filipino patients with musculoskeletal disease or disorders.

Moving forward, the marching orders have been given to all subspecialty societies and local chapter organizations, to direct their activities and outreach programs to the "unserved and underserved communities" of the country. Fellows were encouraged to present themselves to the leaders of the local government units (LGUs) where they practice, and work with them in the planning and implementation of effective programs related to orthopedic issues and concerns in their locality. Education of local health workers will be given more focus, especially on the prevention and early diagnosis, including treatment of mild and minor cases, as well as catching late-stage conditions that need referral to specialists for more

aggressive and complex management. The Association will continue to collaborate with government and non- government agencies in the promotion and implementation of programs related to the universal and primary health care in the country.

The POA being more involved in national health issues, and community service, will be in a better position to help more patients, in more remote locations. This will allow us to participate in the decision making of health policies and programs in our locality, and in the national stage as well. This is truly a testament to what the Philippine Orthopedic Association stands for!

A Solid Start of an Amazing Year

The Philippine Society of Otolaryngology - Head and Neck Surgery (PSO-HNS), offers unique opportunities to its partners and stakeholders, backed by the strength and commitment of its 993 fellows. With 67 years of operating experience, the PSO-HNS is embarking on a period of exceptional growth, grounded in its commitment to operating integrity, financial discipline, and fiscal accountability guided by its core values.

There are 993 ORL-HNS fellows serving 113 million or about 1 ENT doctor to about 113 thousand Filipinos.

The Philippines has a lower physician to population ratio compared to the world average, highlighting the high inequality in the number and distribution of ENTs. The PSOHNS aims to inform policies that improve access to ENT services nationwide, such as scale-up of training of ENTs and incentives to distribute specialists. At present, the PSO-HNS is composed of 10 Subspecialty Academies and 8 Component Chapters. This assures the presence of an ENT doctor in all parts of the country.

Hypospadias Repair Workshop | March 27, 2023

Reyes Memorial Medical Center (JRRMMC) – Section of Pediatric Surgery, together with the Philippine Society of Pediatric Surgeons (PSPS) welcomed in the country Dr. Nyo Yoke Lin, a consultant of Pediatric Surgery and Urology from University Children's Medical Institute, Department of Pediatric Surgery in National University Hospital, Singapore, last March 27, 2023. He performed two hypospadias repair procedures in NCH, assisted and observed by consultants and fellows of pediatric surgery and pediatric urology. The surgeries were followed by his discussion of the surgical techniques performed and the latest innovations in the perioperative management of hypospadias. The discussion, which was held in the NCH Department of Surgery with online streaming via Zoom, was moderated by Dr. Russel Alegarbes.



Philippines Set to Host the Biennial Convention of the GICS | March 29, 2023

The Global Initiative for Children's Surgery (GICS) is an initiative launched in 2014 with the aim of addressing the gap in pediatric surgical care in low- and middleincome countries. A meeting with the GICS officers has the Philippines set to host the biennial convention on February 22-25, 2024. This convention will tackle topics aimed at improving the quality and accessibility of surgical care for children in low-resource settings and to reduce the global burden of surgical disease among children.

Three-day Surgical Outreach Activity in Apayao

Surgery is an essential part of all health systems. With one in four people undergoing an operation in their lifetime, it remains the mainstay of treatment for most diseases requiring non-medical intervention. Even before the COVID-19 pandemic, it was estimated that around 5 billion people lacked access to surgical care and 143 million more operations per year were required globally to address the surgical backlog. The pandemic has acutely worsened the situation and placed a spotlight on the need for change in how surgery is delivered. During COVID-19 surges, at least 28 million elective operations were postponed around the world, with the backlog further increasing during recovery.

Focused surgery performed in geographically isolated and displaced areas where unmet needs are most palpable has been a crucial strategy utilized in addressing the pervasive problem of surgical backlog. Recognizing this urgent need and call for immediate action, the Philippine Association of Laparoscopic and Endoscopic Surgeons or P.A.L.E.S. North Luzon Chapter in cooperation with the Philippine College of Surgeons (PCS) North Luzon Chapter and the Philippine College of Surgeons (PCS) Surgery to Underserved Regions for Education (S.U.R.E.) Commission embarked on a 3-day surgical outreach activity to cater to the surgical needs of patients from Apayao, a landlocked province in the Cordillera Administrative Region in Luzon and is considered as one of the least densely-populated provinces in the Philippines.



On a balmy evening of January, a team of physicians departed from Dagupan City and travelled by air to Tuguegarao City before journeying by land to the Municipality of Conner in Apayao. The team led by Dr. Vivencio Jose "Juvie" Villaflor III, General Surgeon with interest in Minimally-Invasive Surgery and current Vice-President of the Philippine College of Surgeons, PCS Fellows Dr. Jose Bulatao III (PCS NLC Presindet), Dr. Jeffrey Cayabyab, Dr. Ralph Lazarus Rapacon and Dr. Karlo Marco "KMO" Orduña, anesthesiologist from Dagupan Doctors Villaflor Hospital rendezvoused with a team of surgeon volunteers and healthcare workers from Conner District Hospital (CDH), a Level 1 50-bed capacity DOH-retained hospital which was created by virtue of Republic Act 7850 in 1994 during the administration of former President Fidel V. Ramos.

The CDH contingent led by Dr. Nelson Rigor, Chief of Hospital II and Dr. Michael Mercado, Medical Specialist III and Head of the OR Department, and Dr. Gilsah Fortuno hosted the 3-day outreach activity which provided free surgical services to 20 indigent patients with various conditions ranging from gallbladder stones, hernias, and common bile duct stones. Surgical procedures were conducted employing advanced techniques through Minimally Invasive Surgery (MIS) using state-ofthe art equipment which were provided for by Karl Storz Endoscopy. The highlight of the activity was the conduct of simultaneous live surgery involving complicated cases in 2 separate venues - Conner District Hospital in Apayao and Villaflor Hospital in Dagupan City. The operations were viewed in real time by consultants, residents and fellows-in-training as part of the P.A.L.E.S. Pre-Mid Year Convention activities through the auspices of the Endoscopic Laparoscopic Institute and participating health care institutions. Proponents of MIS were on hand to perform the complex surgical procedures and share their expert knowledge and skills with other young and aspiring surgeons. The activity also provided an opportunity to make cutting-edge surgical technology performed by trained specialists available even to the marginalized segment of population residing in geographically isolated and displaced areas.





Evidence has shown that substandard care wastes significant resources and harms the health of populations, destroying human capital and reducing productivity. Quality of care, especially patient safety, is essential to creating trust in health services. It is also key to global health security, which starts with local health security, and in turn depends on high-quality frontline health services. Quality health services not only prevent human suffering and ensure healthier societies, they also ensure better human capital and healthier economies.

Too often, quality is perceived as a luxury that only rich countries can afford. Building quality health services requires a culture of transparency, engagement, and openness about results, which are possible in all societies – regardless of their income level. Around the world and in our local setting, lessons abound on what works and what does not, providing a rich foundation from which to rapidly scale up a quality revolution. Technological innovation plays a key role in offering new ways to expand high-quality health care services more rapidly, and at an affordable cost.

A patient-centric approach has to be the core of quality. People and communities must be engaged in the design, delivery, and ongoing assessment of health services to ensure they are built to meet local health needs – rather than those of donors, commercial or political interests, or because "it's always been done that way". Focusing on quality is critical, but leadership must also focus on celebrating excellence; communicating transparently; and fostering collaboration across clinical teams, as well as with patients, and civil society – including patient groups, non-governmental organizations, and grassroots community groups.

The surgical outreach activity in Apayao is proof of concept that quality and safe surgery for all IS possible. With the right mix of inter sectoral collaboration, professional competence and dedication to public service, the promise of better delivery of surgical care has become more doable and achievable, even to the most remote locations under the most unfavorable conditions. It is also a resounding reminder of the endless possibilities that can happen once the right elements are aligned to accomplish a common purpose. -



The Gift of Giving Quality and Safe Surgery for All Through Care, Cure, and Collaboration

A patient-centric approach to delivery of surgical services has to be the core of quality. People and communities must be engaged in the design, deliberation, and delivery of health services to guarantee they are built to meet local health needs – rather than those of donors, commercial or political interests, or because "it has always been done that way".

Putting a premium on quality is important, but leadership must also focus on celebrating excellence; communicating transparently; and fostering collaboration across clinical teams, as well as with patients, and civil society – including patient groups, industry partners, nongovernmental organizations, and grassroots community groups.

In the advent of the implementation of Universal Health Coverage (UHC) in key pilot areas which includes the Province of Pangasinan, and in light of the disruption in surgical care brought about by the pandemic, the matter of addressing unmet surgeries has never been more relevant. The barometer by which we measure progress in UHC is through effective coverage of essential health services and financial protection without the danger of financial bankruptcy. But even if our country achieved essential health coverage and financial protection, health outcomes would still be poor if services were low-quality and unsafe.

Evidence suggests that substandard care wastes significant resources and harms the health of populations, destroying human capital and reducing productivity. Quality of care, especially patient safety, is imperative if we are to re-establish trust in health services. It is also key to global health security, which starts with local health security, and in turn depends on high-quality frontline health services. Quality health services not only prevent human suffering and ensure healthier societies, they also allow for better human capital and healthier economies.

Cognizant of all these realities, the Philippine College of Surgeons (PCS), which has served as the umbrella organization for all surgical cutting specialty societies in the country since its inception in 1936, has incessantly endeavored to ensure that accessible, and equitable surgical services are made available in underserved areas through its humanitarian arm, the Committee on Surgery in the Underserved Regions and

for Education or S.U.R.E. Commission. Aligned with this overarching objective, the Commission organized a SURGICAL OUTREACH ACTIVITY in partnership with the World Surgical Foundation Philippines (WSFP) together with the Dagupan Doctors Villaflor Memorial Hospital (DDVMH) and the MBP - Blessed Trinity General Hospital (MBP-BTGH) to address the surgical backlog in selected areas in the Province of Pangasinan. The outreach activity was conducted from November 27-30, 2022 which ran concurrently in the City of Dagupan and the Municipality of Mangatarem. Major operations for a wide range of diseases were done by conventional open surgery and by endoscopic or laparoscopic approach. These complex procedures, including minor surgeries were performed by both local and international surgeons at no cost for the benefit of deserving indigent patients suffering from a various ailments.

The invited luminaries were led by Dr. Domingo Alvear, a pediatric surgeon residing in Harrisburg, Philadelphia and founder of the World Surgical Foundation; Dr. Gazi Zibari, native of Kurdistan and an acclaimed humanitarian and transplant surgeon who presently holds the position of Chief of the Division of Transplantation and Director of Wills-Knighton Regional Transplant Program in Louisiana; and Dr. Quyen Chu, Chief of Surgical Oncology and Director of the Hepato-Pancreato-Biliary Service in the Louisiana State University who is also a world-renowned researcher and educator. The local counterparts were led by Dr. Catherine Teh, Chief of the Hepato-Pancreato-Biliary Service at the Makati Medical Center and member of numerous local and international specialty societies; Dr. Ramon Inso, General Surgeon and incumbent PCS President; Dr. Vivencio Jose Villaflor III, a General Surgeon with interest in Minimally-Invasive Surgery, Hospital and Medical Director of the DDVMH and concurrently, Board of Regents of the PCS; Dr. Beda Espineda, Pediatric Surgeon from Philippine Children's Medical Center and Commission Director of PCS S.U.R.E.; Dr. Marcus Lester Suntay, Pediatric Surgeon and Head of the WSFP; Dr. Jaime Maron, General Surgeon and Medical Director of MBP-BTGH; Dr. Roderick De Leon, Vice-President for Internal Projects of WSFP and practicing General Surgeon from Our Lady of Peace Hospital; Dr. Ralph Rapacon, Surgical Oncologist and President of the PCS-North Luzon Chapter; Dr. Mayeen Fernandez, General Surgeon and President of the Philippine Society of General Surgeons (PSGS) - North Luzon Chapter; Dr. Jeff Wong, Plastic Surgeon from DDVMH and Dr. Kyle Gervin Ong, General Surgeon specializing in hepato-pancreatobiliary diseases who holds practice in MMC.

They were joined by prominent surgical practitioners who represented their affiliated societies namely Dr. Miguel Mendoza (Asian Hospital and Medical Center / AHMC); Dr. Raymond Ong (Philippine Association of Endoscopic and Laparoscopic Surgeons / PALES and Fellowship Consortium on Advanced Laparoscopic Surgery/ FOCALS); and Dr. Banny Genuino (Endo-Laparoscopic Institute / ELI).

In the weeks leading to the commencement of the surgical outreach activity, a rigorous screening process was conducted under the supervision of Dr. Mona Palisoc, Head of the Urgent Care Unit of DDVMH and Marie Fe G. Dela Cruz, Chief Nurse of DDVMH in order to ensure proper patient selection and safety. Ample support was extended by Dr. Marissa Umali, Dr. Karlo Orduna, Dr. Delia Guibani, Dr. Magdalyn Quilaton, Dr. Luis Buencamino, Dr. Fred Enrile and Dr. Jeffrey Corpuz who provided pre and and perioperative anesthesia services under the able leadership of Dr. Maribel Valenzuela, President of the Philippine Association of Anesthesiologists (PSA) - Northern Luzon Chapter. The surgical outreach would not have been possible without the untiring service extended by the nursing staff of both DDVMH and MBP-BTGH together with volunteers from the WSFP and the Operating Room Nurses Association of the Philippines (ORNAP).

The activity was also coordinated through the generous support of industry partners such as Karl Storz Endoscopy Philippines, Medtronic, Health Solutions, Biosite Medical Instruments, Elan Vita Diagnostic Solutions, SonoScape, Braun, Cathay Drug Company, Inc., and ClearVue Pharma. Other partner-shareholders who gave their invaluable support included Unilab Foundation, Inc., Philippine Red Cross Pangasinan Chapter, Inner Wheel Club of Uptown Dagupan, CSI Group of Companies, University of Life and Sun Life Foundation. Logistical support was provided by the Municipal Government of Mangatarem and the Provincial Government of Pangasinan.

Prior to admission, patients were screened individually and appropriate diagnostic examinations were performed free of charge. In addition, all participants including healthcare workers were subjected to testing for SARS-CoV-2 in compliance with prescribed health protocols. As part of pre- operative care and for academic purposes, a Pre-Operative Conference was conducted on the initial day with the panel of reactors consisting of Drs. Alvear, Zibari, Chu, and Teh who carefully "dissected" cases scheduled for surgery while generously sharing their knowledge and expertise on how to better manage the patients. Participating training institutions included the Ilocos Training and Medical Center, Region I Medical Center, Ospital ng Muntinlupa, AHMC, ELI and FOCALS.

After the last operating room theater had been vacated, a total of 120 individuals were recipients of quality and safe surgery for their respective ailments - cases ranging from complex malignant liver tumors, complicated cases of hernias, thyroid and breast masses, cleft lip and palate and various bowel abnormalities which included mostly, gallbladder stones. Surgical procedures that would have otherwise been undoable or plainly inaccessible due to either absence of equipment and expertise or lack of finances were made available utilizing the the best equipment, the best surgeons, anesthesiologists, and nurses while providing the best care possible.

Surgery is an essential part of all health systems. But so is humanity. As Dr. Juvie Villaflor alluded to the words of Hippocrates, "Where the art of medicine is loved, there is also love for humanity." The recently concluded surgical outreach activity is proof that the spirit of altruism and volunteerism is alive and that ordinary people with great talent can perform extraordinary deeds with great love. It also shows that intersectional collaboration is the catalyst which can make effort more efficient and more inclusive.

Too often, quality is perceived as a luxury that only rich countries can afford. We now know this to be untrue. Building quality health services requires a culture of transparency, engagement, and openness about results, which are possible in all societies – regardless of their income level. Around the world and only recently in the thriving City of Dagupan and the quaint Municipality of Mangatarem, lessons have been learned on what works and what does not, providing a rich foundation from which to rapidly scale up a quality revolution.

Fact is, it can be done. And it HAS been done. Because in a world of cynics and skeptics, there are still dreamers and visionaries who dare to care. Who labor hard and play hard, because it is only in mirth and glee that work can be made pleasing to them. Who quietly toil in obscurity to change the world one community at a time... one surgical procedure at a time... one patient at a time.

All because the gift of giving never stops.

Editor's Note: The following is the Speech given on the Master of the Knife 2023 awarding to Dr. Hernan Ang at the Chapter Ceremonies, January 29, 2023)

Dra. Connie Vesagas, President PCS, Dr. Juvie Villaflor, VP, Regents, Dr. Joey Mendoza, Dr. Esperanza Lahoz, Dr. J. Rhoel de Leon, Ma'am Annette Tolentino, Fellows of the PCS Southern Tagalog Chapter, guests, Good Morning.

It is but proper and wholly befitting that our great Chapter recognises and awards our late colleague and dear friend, Hernan as Master of the Knife this year.

If Hernan were here today, present at this very moment, physically - he'd likely be immensely amused at all this fuss. Maybe - Hernan would probably quite characteristically break out into a hearty chuckle and in his usual jocular manner, rib each of us on bestowing him this prestigious award. I suspect he wouldn't take these accolades too seriously - just as most confident but modest men do not take unwanted attention - or themselves - seriously. I've known him to be a pretty unassuming fellow - simple, self-effacing, shy. But I feel he would nonetheless be grateful for the recognition.

Being a total outsider on my entrance to Perpetual Help Medical Center way back in 1997, Hernan was so very accommodating. It was like tentatively entering a room full of strangers. And then , there's one who smiles at you. That was Hernan. From then on, I saw him immediately as a "Kuya" and in time, started call him "Bossing". But, of course, he could hardly to be described as bossy.

He made himself available to many of us. I would chance to go to his clinic and discuss professional and personal matters and he readily dispensed invaluable advice.

I do remember the rare times I'd call on him during an intra-op procedure in order to get his immediate opinion.

We somehow quite naturally gravitated to each other. We were involved in a number of workings in the Surgery Department, discussing the residents or the medical students. He undertook his responsibilities as the Executive Training Officer seriously with due dedication and care.

During conventions and chapter activities, we invariably stayed side by side. (Dr. Inso was already "unreachable" and was moving in higher circles.) So Bossing and I kept each other company.

I can only recall the good side of Bossing Hernan. Not once did I ever witness a dark side. Never. Never did I see him lose his temper. Bossing was more known for his cheerful banter and the cracking of appropriate quips. Jeannie, his wife, told me the same thing: "napakabait" with a nary mean bone in his body. The Bossing I knew was thoughtful and kind. One memorable incident readily comes to mind: Hernan went out of his way to do a timely call to me when I was on my way to the PCS for a Committee meeting, pre-Zoom period. Having heard of the latest traffic situation on the radio, he contacted me on-the-spot to warn and cautioned me to turn back immediately instead because of the nightmarish CARmageddon conditions at EDSA that evening. That was very much appreciated.

I did personally observe some slight trepidation and actual apprehension when he assumed the Chapter presidency back in 2008. To confide and admit such to me was indeed a testament of his humility.

During the severe lockdown period, we would continue to meet online periodically in our Resident's Training Committee. In one of those Zoom meetings, last December 2020, much to our startlement, it was noticed that he was now confined in the hospital. Bossing brushed this off as nothing of concern. That was his last meeting with us. 'Til the difficult end, Hernan responsibly carried out his duties.

I guess one vital lesson we can learn from Hernan's life is that it is how a person makes you feel - over that individual's accomplishments, achievements and successes - that truly matters.

As I have mentioned during Bossing's necrological services: Hernan was truly a decent individual and was the kindest there was. He was an extremely likeable human being. My only regret was I never told him that myself.

Our chapter surely misses him.

We all agree that our colleagues who sadly passed away in the line of service during the terrible period of the COVID pandemic are heroes. Hernan is our hero.

Hernan has been called by the Divine Healer for a higher service.

Congratulations Bossing Hernan!

Maria Concepcion C. Vesagas, MD, FPCS President, Philippine College of Surgeons 2023

A future career in Biology - specifically in the dynamic field of Genetics - and a burning desire of being dedicated to the academe. That, would you believe, was the early career aspiration of our PCS President Dra. Maria Concepcion C. Vesagas.



Having finished her secondary schooling at the St. Theresa's College Manila with first honors, Dra. Vesagas pursued her Pre-Med studies in B. S. Biology in 1977 at the University of the Philippines. She graduated with distinction as cum laude in 1981. She was a member of the U.P. Pre-Medical Honors Society and the Phi Sigma Honor Society, Alpha Chi Chapter at the Diliman campus. But her father smartly intervened by suggesting to his daughter that she could still chase her dream of becoming a Biologist within the specialized branch of Genetics and accomplish this and more as a physician. Dra. Vesagas followed her father's advice.

She enrolled for medical studies at the University of the Philippines Manila in 1981 and graduated in 1985. Dra. Vesagas did her medical internship in the same institution from 1985-1986. After passing the medical boards, she decided to do residency at the Philippine General Hospital. During that period wherein her selected specialty was then a male-dominated field, Dra. Vesagas elected to go into General Surgery training undaunted. When asked why she chose the field of Surgery, she replied, "It was a toss between Surgery and Obstetrics. During my rotation as a clinical clerk in Surgery, Dr. William Sy, the team captain then remarked that I should go into Surgery."

She finished her training in General Surgery in 1991 and shortly thereafter successfully hurdled the Diplomate Board examination.

Dra. Vesagas has held several positions in the PCS and in the various subspecialty societies.

Aside from currently being the President of the Philippine College of Surgeons, her current positions are as follows: Chairman of the Board, Philippine College of Surgeons Foundation, Inc; Trustee, Association of Women Surgeons of the Philippines; Officer-in-Charge, Ethics Review Board, 'Amang' Rodriguez Memorial Medical Center; Consultant, General Surgery, Department of Surgery, 'Amang' Rodriguez Memorial Medical Center; Visiting Consultant, Department of Surgery, Cardinal Santos Medical Center.

On a gladdening full circle note: In 2013, Dra. Vesagas was still able to pursue further studies on her leadoff passion: Introduction to Biology – The Secret of Life at the Massachusetts Institute of Technology on a MOOC platform. The following year, she completed another online course on the Principles in Written English given by the University of California while simultaneously carrying out the duties as Editor-in-Chief of the PCS Newsletter. Despite her hectic schedule, she has also remarkably made time for competitive sports by trying out and becoming a member of the Manila Dragons Dragon Boat Rowing Team in 2006, of which she was even awarded Most Improved Paddler on just her second year in the national team. The MDDBRT is one of the pioneer dragon boat teams in the Philippines and in a span of over 20 years has competed and won in a number of local and international boating races in different destinations including Melbourne, Guangzhou, Hong Kong, and Boracay.

Dra. Vesagas has numerous scientific & creative publications. Of the latter notably is the publication of the "Eight Decades of Philippine Surgery" by the Philippine College of Surgeons Board of Regents in 2016 of which she was editor.

The Newsletter was able to ask a few questions of our PCS President at the start of the year.

Were there any personal or family experiences that managed to shape your character and outlook today?

Having children and having a differently abled child has certainly shaped my outlook. Patience, looking for the good in people and having an optimistic outlook always helps.

What advice can you give our young surgeons?

Approach your profession with passion without forgetting that behind the patient is a person and a family who is concerned with outcomes. Continue to learn about the profession but be open to learning new things outside the confines of surgery. Make new friends and continue to have ties with your old friends. And always be humble and kind.

What are your aspirations for the College this year?

The aspirations are not for the year but for a long-term basis. I do not see myself pushing for

a "legacy project" but really making sure that the PCS will continue to grow in terms of membership, relevance to its members; that the College will continue to be significant in Philippine society, contributing to our health system and we be the goto for surgical issues. It may not seem like it is a College aspiration but I would like that the Medical Act be passed by Congress this year in the form that the PCS helped formulate together with the other specialty divisions.


